**Official Notice  
Nominations and Elections  
Local Union 46, IBEW  
2023**

The nominations for officers of Local Union 46 will be held on Wednesday, May 10, 2023, beginning at 5:30 p.m. at the I.B.E.W. Local No. 46 Auditorium located at 19802 62<sup>nd</sup> Avenue S, Kent, Washington. Anyone desiring to be nominated must be present during the nominations or provide a written and signed statement that they will accept the nomination. No member may be a candidate for more than one office. **Anyone nominated to more than one office must choose the office for which they will be a candidate.**

Nominations will proceed in the order of offices as listed in the IBEW Constitution. Each term of office shall be 3 years: President, Vice President, Recording Secretary, Business Manager/Financial Secretary, Treasurer, Executive Board Members (5), Exam Board Members (5).

Candidates who accept nomination may also submit a 500-word or less statement and a high-resolution photograph to the Election Judge by 5:00 p.m. on Friday, May 12, 2023. This statement and photograph will be included in a Voters' Pamphlet to be mailed to all members.

**In order to be nominated, a member must have a minimum of 2 years of continuous good standing in Local Union 46. Good standing means that the member is current in their payment of dues and has been for the 2 years preceding the nominations.**

The election shall be conducted by mail ballot, and they shall be counted on Wednesday, June 7, 2023. All members in good standing shall be mailed a ballot not less than 21 days prior to the above-specified date. Ballots received after 8:00am on Wednesday, June 7, 2023, will not be counted. If a run-off election is necessary, ballots will be mailed out by Tuesday June 13, 2023 and subsequently counted on Wednesday, July 5, 2023. Ballots received after 8:00am on Wednesday, July 5, 2023, will not be counted.


