Local Union Pension	\$4.18
Annuity	\$1.00

**All other fringe benefits and ancillary fees remain unchanged.*

Contractors must submit a market recovery (Grant Request Form) request at least 48 hours in advance for each job to be eligible for this relief. The Union may reject any individual request as long as that rejection is at least 12 hours in advance of the bid time listed on the Grant Request Form. Apprentices wage percentages shall be based off the above listed Journey Wireman's wage. Any employee requesting a lay off from this job shall be granted one. No applicant for employment shall be required to accept a dispatch to this project.

CONDITIONS:

Contractors utilizing this Grant Agreement must submit a Grant Request Form to IBEW L.U. 46 and a courtesy copy to Puget Sound Chapter, NECA. There is a standing approval for jobs that meet these conditions until the expiration of this standing grant. Unless notified by the Union of a rejection to the employer's request 12 hours in advance of the listed bid time, the request is approved. All other terms and conditions not mentioned herein of the Work Recovery Program apply. If you are bidding a job with estimated hours over 3000, call Greg Galusha at 206-354-6626 to determine if you can bid the job utilizing this Agreement. This Standing WRP Grant will be in force through May 31, 2010, unless extended by the parties. Any job bid on or before May 31, 2010 can be completed under the terms of this Agreement.
