Dear Sirs and Brothers:

This concerns the recent Memorandum of Agreement with the International Brotherhood of Electrical Workers and the Sheet Metal Workers International Association dated October 15, 1969, and covered by my letter of October 22, 1969.

At a recent meeting with President Carlough it was mutually agreed that Item 5 (Motors and Sheaves) on page 3 of the Agreement is now deleted.

The enclosed redated Agreement supersedes any previous understandings between the organizations.

You are to use these to settle disputes that cannot be settled on the local level. Should some local agreement or settlement be in effect and both parties want to continue such agreement or settlement, there will be no objection from this office. If, for any reason, such local arrangements or agreements become inoperative to the point where international intervention by request or initiation becomes necessary, then the enclosed settlements on these items shall prevail.

The Committee will continue to consider unresolved items between our organizations.

Memorandum of Agreement

December 16, 1969

Between the Sheet Metal Workers International Association and the International Brotherhood of Electrical Workers. This Agreement supersedes any previous understandings between our organizations.

1. Units

- (a) Electric unit heaters, not duct connected, shall be the work of the I.B.E.W.
- (b) Electric unit heaters, duct connected, shall be the work of the S.M.W.I.A.
- (c) Completed package room cabinet type electric heating units, with or without thru wall fresh air intake, shall be the work of the I.B.E.W.
- (d) Completed package room cabinet type electric heating units requiring air intake and/or distribution duct to be connected, shall be the work of the S.M.W.I.A.
- (e) Completely assembled units or disassembled multi-sectional electric heating units, whether or not duct connected, consisting of fan sections and/or mixing box section, and/or electrical element section, and/or filter section shall be handled and installed by S.M.W.I.A.
Electrical element, if separate, of the unit, said element to be handled and installed by I.B.E.W.

2. A. In-Duct Heaters

- (a) Duct to be opened and prepared by S.M.W.I.A.
- (b) Heating element to be handled, installed and wired by I.B.E.W.
- (c) Closing of openings, when necessary after installation of heating unit will be performed by S.M.W.I.A.

B. In-Line Duct Heaters

(On new or existing installation)

- (a) Duct heaters (in line installed) supported independently from duct shall be handled and installed by I.B.E.W.
- (b) Duct heaters (in line installed) supported by duct shall be handled and installed by S.M.W.I.A.

3. A. Sill Line and Baseboard Convection

(Completely Assembled)

Baseboard and Sill line units completely assembled such as "Chromalux" or similar type shall be handled and installed by

I.B.E.W. All filler pieces will be installed by S.M.W.I.A.

B. Sill Line and Baseboard Continuous Convection

- (a) Back plates to receive or to which heating element are attached shall be installed by I.B.E.W. including the installation of electrical heating elements.
- (b) All other back plates, fillers and front covers shall be installed by S.M.W.I.A.
- (c) Custom shop fabricated and/or field fabricated back plates and/or front covers shall be fabricated and installed by S.M.W.I.A.
(This paragraph (c) does not apply to catalog items.)

4. Infra-Red Ovens

- (a) Installation of infra-red ovens, including bolting of sections together, and duct work and blowers including hangers and

supports exclusively for these items shall be the work of the S.M.W.I.A.

- (b) All electrical wiring, reflectors, heating units, raceways and motors (except where motors are installed on equipment) including supports exclusively for these items, shall be the work of the I.B.E.W.
- (c) Where supports are integrated with the air duct, the installation shall be by composite crew and in the event portions of the casing act as a reflector, then such portions shall be installed by a composite crew.
